At the agreed upon deadline you will be expected to submit a final report detailing the use of the funds, photos where possible, details of how the funds enabled you to benefit needy animals and their human owners, including quotes from owners where possible. These will help us share with donors how the fundraising conducted by Ocean Shores Woof-a-Thon has benefited our community.

Lastly, we expect you to send one or more representatives from your organization to the fundraising event (see date below), to speak about your organization. You should include details about the fundraising event on your website, in your newsletter and in any other ways possible in order to help us make the event successful for all. You also may need to be available for press interviews or other media relations which will be scheduled in advance with you.

Also, Ocean Shores Woof-a-Thon has your permission, if you are selected as a beneficiary, to publicize your organization on our website, in materials, verbally and in all ways possible as a selected charitable beneficiary of our fundraising efforts.
